

PRIZE GAME RULES

Official prize game rules of our prize game “LET'S CELEBRATE TOGETHER! – 10 YEARS OF GALLOMAN”

*Please read
the prize game rules and the conditions for participation carefully.
Participation in the game means automatic acceptance of the rules for participation.*

I. Organiser of the prize game

The organiser of the prize game “LET’S CELEBRATE TOGETHER” (hereinafter referred to as the Prize Game) and at the same time the comprehensive administrator of the Prize Game and prize draw (hereinafter referred to as the Organiser) is Galloman Hungary Kft (registered office: 1113 Budapest, Dávid F. u. 11., II. em. 1., company registration number: 01-09-951073).

II. Persons who may participate in the Prize Game

1./ Our corporate Clients as follows (hereinafter referred to as Participants) may participate in the Prize Game:

- a) those that requested Translation or Interpretation services from the Organiser between 8 December 2010 and 31 December 31 2020 for a value of at least HUF 1000, and
- b) that accept the Prize Game rules and consent to the processing of their data and declare that the data provided are true
- c) that are not subject to any condition for exclusion from the Prize Game.

2./ The following entrants are not entitled to participate in the Prize Game, even if other conditions for participation are met:

- a) an owner, member, senior officer or employee of the Organiser,
- b) relatives of the persons listed under point a), as defined under Section 8:1(1)(2) of the Civil Code,
- c) any person who participates in the Prize Game in a fraudulent, illegal or unethical manner,

3./ If an entrant does not comply with the conditions under these Rules, the Organiser shall exclude the entrant from the game and the draw. The Organiser shall inform the excluded entrant of their exclusion from the game and the draw.

III. 4. Duration of the Prize Game:

The Prize Game will take place between 15 October 2020 and 7 January 2021.

IV. Prizes awarded during the Prize Game

A total of the following 3 prizes will be drawn at the draw of the Prize Game indicated under point V:

1st Prize: Translation or Interpretation for a value of HUF 100 000 + VAT

2nd prize: Translation or Interpretation for a value of HUF 50 000 + VAT

3rd prize: Translation or Interpretation for a value of HUF 25 000 + VAT

The above prizes will be awarded in the form of a discount in the event that an order is placed.

The discount may offset at the most 90% of the value of any given order: if the value of the order is less than the discount, it may be offset in several instalments up to the end of 2021 inclusive.

2./ The Organiser shall not draw any other prize than those indicated under point IV. and shall not provide any other supplementary services.

V. Participation in the game

Every Participant who satisfies the conditions indicated under point 1./ and fills in the registration form attached to these Rules completely and truthfully; namely enters their company name, contact email address, accepts the Prize Game Rules, consents to the processing of their data and declares that the data provided are true, shall participate in the Prize Game.

VI. Date and place of the draw

The draw shall take place on the Organiser's premises on 7 January 2021.

VII. Administration of the draw

1./ The prizes shall be drawn using a random number generator based on the data on the registration forms received by the Organiser at the latest by 6:00 PM on 7 January 2021.

2./ The Organiser shall also draw 1 person as a reserve winner at the draw. The method, place and date of drawing the reserve winners are the same as those of the winners. The reserve winners shall become eligible for a prize in the order that they are drawn if any winner/reserve winner before the given reserve winner fails to comply with any condition indicated in the present Rules and is therefore excluded from the Prize Game after their entry-form was drawn.

3./ The draw lasts until the winners of the prizes are drawn; accordingly, the draw shall consist of a single drawing.

4./ The registration forms participating in the Prize Game shall be retained by the Organiser for 90 days following the draw and the entry-forms and any related documents shall be destroyed after this date.

VIII. Award of the prizes

1./ The winners of the Prize Game shall be notified by the Organizer at the email address or telephone number provided by the entrant within 36 hours of the draw in order to reconcile the data. The Organiser shall notify the winners of the results of the draw in writing at the email address provided by the entrants on their registration forms. At the same time as the notification,

the Organiser shall also publish the winners (by indicating their company names) at the website www.galloman.hu and the Participant hereby consents to this.

2./ The winner is entitled to use their prize by 31 December 2021 at the latest.

3./ The winner shall be notified in writing by the Organiser of the date and place where the document certifying the prize will be handed over. The prize shall be handed over by the Organiser to the winner if the winner credibly certifies their identity information and declares that they are not subject to any of the exclusion criteria under these Rules.

4./ The prize may be received by the winner's agent in place of the winner if an original copy of a power of attorney in the form of a private or public document is handed over to the Organiser handing over the prize.

5./ The prize cannot be exchanged for cash or any other thing or right of pecuniary value and cannot be transferred. The winner assumes any risks involved in using the prize.

6./ If a winner does not use their prize before 31 December 2021, that winner shall definitively lose their entitlement to use the prize awarded.

IX. Costs and the public burden involved in a prize

1./ Any other costs related to the winner, the prize or receiving the prize, other than the public burden indicated under point VIII.1. (for example travel costs, shipping costs, postal costs), shall be borne by the Organiser.

X. Rules concerning the processing of personal information and data reporting

1./ By registering for the Prize Game, the Participant acknowledges and accepts all the terms and conditions of the Prize Game Rules and explicitly consents to the Organiser publishing their name and their representative's name, as well as all or parts of any video, audio and film recording made of the award ceremony of the prizes, in case they win, to be used in advertising campaigns by the Organiser, without any limitations in time or number or any extra fee. The Organiser reserves the right to hand over the prizes to the winners as part of a public event. The data shall not be handed over to any third party without having informed the data owner and having obtained their prior authorisation, with the exception of cases specified by legislation.

2./ By registering for the game, the Participant consents to the Organiser, as data processor, processing the personal information given during registration and - in case of a win - the data concerning the prize in question and its value and the winner's delivery address. The same applies to pictures and audiovisual recordings of the winner that the Organizer shall take of the Participant in the course of the game or following its completion (hereinafter referred to only as personal information). Providing personal information is on a voluntary basis. The data will not be transferred to and will not become accessible to any third party other than the data processor. The data is processed for the purpose of administering the present game and - in the case of a winning Participant - of managing taxes, publishing the results of the game on news media and

the game Organiser's advertising materials for one year following the completion of the game and the settlement of any claims arising from the game.

3./ Personal data are processed automatically, in electronic form. Furthermore, the Participant acknowledges that they are entitled to the rights under Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information. The consent given by the Participant for the processing of his or her personal information may be revoked at any time at the Organizer's address, without any charge (if the consent to processing is withdrawn, the personal information shall be deleted or destroyed in another way); the Participant has the right to access his or her personal data (including information concerning their extent and the purposes of their processing, as well as all available information on their sources), to correct them, to complete any incorrect personal data or to object and request their destruction, etc. If any doubt arises as to whether the processing of personal data is contrary to the protection of the Participant's private or personal life, or is contrary to the law, the Participant may request from the Organiser an explanation of the erroneous situation and an immediate rectification or may turn directly to the National Authority for Data Protection and Freedom of Information or may assert his or her claim before the courts.

XI. Miscellaneous provisions

1./ The Organiser shall not be liable for any technical problems arising during the transfer of data through the Internet or another electronic means.

2./ The Organiser reserves the right to modify the rules of the game at any time, or to cancel the game without giving any reason or compensation, as well as to replace the prizes with other prizes of a similar type and corresponding value. Any modification of the rules of the game, cancellation of the game or the replacement of certain prizes with other prizes shall take place in writing and shall be published on the website www.galloman.hu.

3./ Participation in the game or replacement of the prizes with money are unenforceable. The Participant is not entitled to demand that a prize be replaced, to lodge a complaint concerning the prizes in any way or to assert any rights arising because the prizes received are lacking in conformity. Furthermore, the Organiser is not liable for any damage that the Participant may suffer due to their participation in the game or due to the prize obtained.
